

INSTRUCTIONS FOR FILING OF PETITIONS

- 1. Circulators must sign first line of all petitions he/she circulates.**
- 2. Circulators must sign the oath on the back of the petitions and have it notarized.**
- 3. Signatures must be of registered voters within the City of Plainfield.**
- 4. No person can sign a petition for more than five candidates.**
- 5. A minimum of 100 valid signatures is needed for a name to be placed on the ballot.**
- 6. All petitions are due on or before 4:00pm September 7, 2012.**
