Councilmanic Resolution Authorizing the Adoption of the City Council Meeting Schedule for the Year 2015

WHEREAS, Public Law 1975, Chapter 231, Section 13, requires a public body to post and maintain posted and to distribute to designated newspapers and to further file with the Municipal Clerk for the purpose of public inspections, a schedule of the regular monthly meeting of such public body to be held during the calendar year; and

WHEREAS, Pursuant to Section 2:2-9(a) as amended, of the Municipal Code the Council shall convene a regular meeting on the second Monday of every month at 8:00 p.m. in the Municipal Court-Council Chambers, 325 Watchung Avenue or such other place as may be established by resolution and public notice, except that when any such regular meeting day falls on a legal holiday the meeting shall be held the same hour and place on the next day which is not a legal holiday, unless the Council shall otherwise provide by resolution; and

WHEREAS, In preparation for the regular council meetings to be held on the second Monday herein described, the Council shall convene an agenda/work meeting on the first Monday of every such month except that when an agenda/work meeting day falls on a legal holiday, the meeting shall be held the same hour and place on the next day which is not a legal holiday, and which agenda/work meeting shall be convened in the Municipal Court-Council Chambers, 325 Watchung Avenue or such other place as may be established by resolution and public notice; and

WHEREAS, Public Law 1975, Chapter 231, Section 3-D, provides that where the annual notice in compliance with sections of the subject act, set forth the location, time and date of any meeting, no further action shall be required for such meeting, now, therefore, be it
