## **Summary:**

City of Plainfield, Mayor Adrian O. Mapp Youth Summit on Education & Employment was a success. Plainfield youth were moved and motivated by the keynote speaker, Dr. Marc Lamont Hill. He gave the youth a realistic perspective of the impact(s) education and employment can have on future achievements. The goal to recruit 50 youth and over 5 organizations was achieved. Plainfield youth took advantage of the opportunity to familiarize themselves with 23 different organizations, which could be very beneficial to their education and employment status. Throughout the event *Urban One Radio*, an online Indie radio station founded by Plainfield Young adults, interviewed Plainfield youth on their outlook and opinions of the Youth Summit.
